The terms of reference of the District Social Audit Committees are as follows:-


- 1) To supervise / scrutinize the overall functioning of the ICDS schemes.
- 2) To ensure co-ordination and full utilization of resources-both from the Government and the Community.
- 3) To utilize available resources and channels for delivery of clear and simple messages to the Community for full participation of children, mothers, adolescent girls and Village Level Coordination Committees in the scheme.
- 4) The tenure of the Committees shall be for a period of 3 (three) years.
- 5) The Committees shall sit quarterly.
