**Terms of Reference of the Governing Body:-**

1. Review and approve strategic and annual work plans that are prepared and submitted to the Governing Body by the participating Units. To consider and approve the Annual Action Plan of the ECD Mission.
2. Receive and allocate project funds to carry out priority research, extension, and related activities within the State. To ensure convergence among the stakeholders/line Departments.
3. Identify other sources of financial support that would help ensure the financial sustainability of the Meghalaya Early Childhood Development Mission and its participating units.

4. Arrange for periodic audit of the Meghalaya Early Childhood Development Mission.
5. Adopt and amend the rules and by-laws of the Meghalaya Early Childhood Development Mission. Make amend or repeal any regulations relating to the administration and management of the affairs of the society.
6. To appoint committees, broads and sub-committees, etc, for such purpose and such terms as it may deem fit and to remove any of them
7. To do generally all such acts and things as may be necessary or incidental to carrying out the objectives of the society or any of them.


